

# MISSION STATEMENT

The mission of Planned Parenthood Columbia Willamette (PPCW) is to provide, promote, and protect access to sexual and reproductive health care. To this end, we provide a broad range of family planning, sexual, reproductive, and other medical services; provide sex education to young people and their educators to increase access to sexual and reproductive health care and healthy sexuality; and advocate for the protection of reproductive rights and freedom in Oregon and Southwest Washington.

### **LETTER FROM ANNE & ASHLEY**

As leaders of Planned Parenthood Columbia Willamette (PPCW), the largest nonprofit provider of sexual and reproductive health (SRH) care in Oregon and SW Washington, we are so proud to lead the organization during one of the most tumultuous years for SRH in recent history. In June, we all witnessed the unprecedented overturning of Roe v Wade – 49 years of legal abortion in this country. This decision was really a crisis moment for access to sexual and reproductive health care in the United States – putting millions of women, trans, nonbinary and gender-nonconforming people at risk of losing access to abortion care, and disproportionally and profoundly impacting our BIPOC communities.

Here in Oregon and Washington, we fought hard to retain the right to reproductive freedom for our patients, while sadly watching access to care stripped away in other parts of the country.

We spent this past year preparing for this fateful event and we could not have done it without the steadfast support from our PPCW community of supporters.

While we prepared for this outcome, we also saw tremendous growth for the organization, despite working through another year of pandemic-related challenges. We embarked on two large construction projects to expand and deliver on our promise of providing excellent patient care and making access to essential health care services available to more people.

During this time, PPCW's frontline staff work tirelessly to serve more than 47,000 patient visits. Their passion and commitment to our mission strengthens

our promise to be there for our patients, as well as our communities, who need us more than ever. And, because of your support and care, our patients know we are here for them – no matter what.

PPCW was thrilled to share the momentous news that we were the recipient of a \$15 million gift – the single largest unrestricted gift in PPCW's 59-year history. This transformational gift from philanthropist Mackenzie Scott will help PPCW to advance health equity in Oregon and Southwest Washington; expand services and access to sexual and reproductive health care; sustain our education and outreach programs; and support and invest in our staff.

Last spring, we signed the lease to the former Four Rivers Health Clinic in Ontario, Oregon, and will begin construction on our newest PPCW health center in the fall. We chose Eastern Oregon to open this location as we have been looking at ways to ensure that people in rural parts of the state have access to the health services they need most. Historically, people in this region have

experienced extreme barriers in accessing the essential health care they need most.

We are excited to share that we broke ground on renovating our Northeast Portland health center thanks in part from a wonderful gift by the Susan H. Hammer Trust of the Oregon Community Foundation. This state-of-the art location will now have a specialty services suite which will allow us to expand abortion care. In addition, we are also planning to fully remodel the current health center - with a focus on serving more patients who seek family planning services.
