A YEAR OF ACHIEVEMENTS AND ONGOING COMMITMENT

In the wake of the first year without the national protections of Roe v. Wade, the Community Action Fund remains dedicated to supporting and protecting California's status as a Reproductive Freedom State. Through our advocacy and electoral work, we will continue to safeguard access to reproductive healthcare services, including abortion, and comprehensive evidence-based sex education at both the state and local level.

In the last election, the Community Action Fund endorsed a record 114 candidates, the most diverse cohort in our organization's history. 61% of these pro-reproductive health candidates secured victories mostly due to the voters' strong support for reproductive rights. On a statewide front, we celebrated the passage of **Proposition** 1, which secured the right to abortion and contraception in the California state constitution. Locally, our efforts contributed to the historic election of the first majority Democratic OC Board of Supervisors in over five decades. As a result, for the first time the majority of the Board are Planned Parenthood supporters.

Thanks to our advocates, elected officials, and donors, the Community Action Fund is leading the way in protecting abortion access. In June, commemorating the anniversary of the loss of the constitutional right to abortion, we organized and hosted a Weekend of Action. Hundreds of community members united across Orange and San Bernardino Counties, to express their opposition to this unjust decision. Our commitment to opposing any legislation that infringes upon our personal freedoms remains steadfast.

As we approach the 2024 election year, it is imperative that we maintain our commitment to regaining our abortion rights in all fifty states. We must identify and support political leaders who will stand with us to empower our communities and resolutely defend abortion rights. A crucial aspect of this endeavor is our unwavering participation in every election to restore our rights and inspire a brighter, more equitable future.
