LETTER FROM THE CEO New reproductive-rights laws in California - and more good news!

Hello Friends,

I'm happy to share some *really good news* with you, despite the horrendous attacks on reproductive rights in other parts of the country. From the Biden administration's recent repeal of the Title X domestic "gag rule" on abortion providers, to Gov. Gavin Newsom signing two Planned Parenthood-sponsored bills into law, to California positioning itself to become a "reproductive freedom state," to wonderful new members of our Leadership Team, there are a lot of positive things happening right now!

I'm so pleased that the affiliate's very first Vice President of Diversity, Equity, and Inclusion Arthur Chan has joined the staff this month. Arthur brings a wealth of experience and expertise, and you can read more about him in this issue of the Full Mar Monte. Also, after an exhaustive search, our new Vice President of Public Affairs Lauren Babb will join the staff in October. You'll learn more about Lauren, who was named by Women's Foundation California as one of 4 Black Policy Movers & Shakers You Should Know, in next month's Full Mar Monte.

Speaking of the Public Affairs team, I want to give them shout-out for the work they did lobbying for two important California bills that were signed into law this month. One, AB 1184, protects patients by ensuring that they will be the sole recipients of confidential communication from their insurance companies. The other, AB 1356, increases fines and penalties on those who harass patients and staff outside our health centers. (See The Big Picture section.)

The Public Affairs team was also instrumental in our campaign against the Title X gag rule, enacted during the Trump administration, that denied federal funding for abortion providers who even discussed abortion-referrals with patients. We were thrilled when the Biden administration repealed the odious gag rule in early October.

It is also very welcome and exciting news that Gov. Newsom, joined by reproductive rights partners and leaders in the state, announced the formation of the California Future of Abortion Council (CA FAB Council). The FAB Council will work in collaboration with researchers, advocates, policy makers, providers, patients and other key constituents to determine potential challenges in the state and recommend solutions that will continue to provide stability and sanctuary for Californians as well as those from out of state who are seeking services here.

This is yet another example of how California continues to lead the way to protect reproductive rights even as places like Texas and Mississippi are eliminating abortionaccess for millions of people who live in those states.


It was recently announced that the U.S. Supreme Court will hear the Mississippi abortion-ban case, Dobbs v. Jackson Women's Health Organization, on Dec. 1. The court will probably decide the case in June 2022, and there is a strong possibility that the conservative majority of justices will uphold the Mississippi law - making the 1973 Roe v. Wade decision virtually irrelevant. And abortion bans would likely and quickly be adopted in at least 23 states.

If states are allowed to restrict abortion to a stage so early that most people don't even know they are pregnant - as we've seen in Texas, where abortion has been banned at six weeks - we know that people will still continue to seek abortion. It just becomes dangerous, and some people in places that have become "abortion deserts" will die.

This is why it's so important that leaders of the two states where PPMM serves patients and communities are committed to making sure that we can continue to provide abortion care for those who live here and for those who come here from other states.

But even more importantly, it's why I'm so thankful for your support and commitment. The work we do at PPIVIN literally changes lives. You are a crucial part of that, and having you on our side makes me proud every day.

What if Roe collapses?

You're invited to a conversation with PPMM leaders - President & CEO Stacy Cross, Chief Medical Officer Dr. Laura Dalton, and Chief Operating Officer Domingue Lee - moderated by Tanuja Bahal, PPFA board member and former PPMM board chair.

We are in a national state of emergency for abortion-access, and it is

intensifying rapidly. Texas is enforcing a draconian and unconstitutional sixweek abortion ban that puts both patients and providers at risk. Florida is preparing to be next in line, with many states not far behind.

And in December, the Supreme Court will be hearing a case, "Dobbs v. Jackson Women's Health Organization, about a 15-week abortion ban in Mississippi that is a direct attack on Roe v. Wade. With the extreme conservative 6-3 majority on the court, the constitutional right to abortion is in grave danger.

This year isn't over yet, and it's already been the worst on record for abortion rights since Roe was adopted. In the first nine months of 2021, nearly 600 abortion restrictions were introduced in states across the country.

However, California has the right to abortion enshrined in its state constitution, and Nevada has laws protecting the right to abortion. Thanks to your support, PPMM health centers will continue to provide abortion care even if *Roe* is overturned. California's seven Planned Parenthood affiliates saw more than 7,000 out-of-state patients for reproductive care last year alone - a vast majority of whom came here for abortion care -- and our affiliate is already feeling the impact of the new restrictions.

Hear from PPMM's CEO Stacy Cross, Chief Medical Officer Dr. Laura Dalton, and Chief Operation Officer Dominque Lee about challenges patients are facing to seek abortion care in "safe haven" states and PPMM's plans to expand care as more states "go dark," severely restricting or completely eliminating abortionaccess.

Championing an inclusive workplace Q&A with new VP of DEI Arthur Chan

For the first time in our affiliate's history, PPMM has a member of the Leadership Team whose role is entirely devoted to cultivating and and advancing the interests of diversity, equity, and inclusion (DEI) at PPMM. The Full Mar Monte caught up with new Vice President of DEI Arthur Chan to learn more about him and his work.

Full Mar Monte: Tell us a little about how you got interested in workplace issues of diversity, equity, and inclusion.

Arthur Chan: I was born and raised in Hong Kong, and I am bi-racial, of Chinese and Portuguese descent. That meant I was often excluded and made to feel something about me was wrong. I felt like I didn't belong, and that was really lonely. I don't want other people to feel that way, and I guess that was the beginning of getting interested in this work - even though I didn't know then that this was something that could be a profession.

FMM: After you became a clinical psychologist in Hong Kong, you began doing DEI work there. What was that experience like?

Arthur: I was a psychologist at a hospital in Hong Kong and was working on DEI initiatives. I was also out as a member of the LGBTQ community, and it turned out that was considered to be a "problem" on the staff of this hospital.

I had talked at one meeting about what it was like to be gay in the workplace, and, later, a senior colleague tried to give me what he thought was helpful advice. He said, "You should be more mindful about disclosing that you are gay." Then he said I should focus my DEI work only on being inclusive of other racial and ethnic groups, including Southeast Asians, as well as people with disabilities - especially if I wanted to be promoted.

He was basically saying I couldn't be myself if I wanted to move up the professional ladder there.

FMM: You decided to move to the U.S. and continue your DEI work here, most recently with the Alzheimer's Association based in San Francisco. What are the differences you have found in terms of the way your work has been received by your U.S. colleagues?

Arthur: One of the reasons I moved here is because I couldn't marry my husband in Hong Kong. People here are definitely more accepting, and most seem to understand what DEI is as well as why it's important. But I found that there are a lot of leaders that talk the talk, but don't walk the walk of really incorporating DEI work into the organizational structure.

When I began talking with PPMM, I was impressed right away to know that the new DEI position would be a member of the Leadership Team. This is such an important way to show real commitment to this work.

FMM: How are you hoping to implement your DEI leadership experience at PPMM?

Arthur: I've recently met with PPMM's DEI Committee, and I love their energy, passion, and ideas! It's great to see the diversity of staff that's represented. I would love to see more health services specialists on the committee as well, so that's something we'll be working on. Their voices need to be heard.

It's so important for the organization that we are not only recruiting a diverse staff, but also that we are retaining and developing them. I'd love for DEI to have more visibility within the affiliate.

FMM: In a nutshell, how would you like all your colleagues in the affiliate to view your new role here?

Arthur: I want people to see me as a partner of staff members, to make this workplace as inclusive and equitable as possible so that everyone feels a sense of belonging, and they can be at their best.

Helping young parents during the pandemic

As hard as it's been for parents of young children to cope with the lifechanging obstacles of this pandemic, imagine how difficult it is for firsttime parents of infants and toddlers, especially parents who are under age 21. They have educational goals for themselves and their children, but may also have urgent needs for housing, income, childcare, food, or health care.

PPMM Teen Parent Support Program (TPSP) Senior Case Manager Mindy A. has been supporting young Santa Clara County parents during this time with frequent phone check-ins, including calls to guide them through online enrollments for public aid programs or even explaining confusing terminology on many of the forms in Spanish or English.

"Whether it's helping them find forms to get a new primary care provider or talking them through an application process for returning to school, I can help them get through the process and help minimize their stress," Mindy said. "I've also helped people apply for jobs and enroll in high school or higher education while they're caring for their children.

"We have really been able to continue our youth advocacy, despite the pandemic, keeping young parents engaged and connected to the help they need."

Being Memorable

Making patients feel welcome and comfortable HSS Maria C. and Clinician Rachel T. at Fruitridge health center

Here's what two people said on their patient surveys recently, after coming to the Fruitridge health center in Sacramento:

- "Maria at reception is a queen. Thank you for helping me. You made a difficult day take a turn for the better."
- "I lost my insurance with Kaiser and was in need of quick medical care. Maria at reception, who is so caring and thoughtful, found a way for me to be seen that day. Rachel, the nurse practitioner, made sure that I received the medicine I needed. I was very impressed with the attentive, professional care I was given. The staff at this Planned Parenthood are over-the-top incredible. They understand how to take care of delicate situations with respect and professionalism. I would recommend this site to any person in need of care."

HSS Maria Cisneros is especially mindful of how difficult it can be for some patients to get in to a health center for care - especially during the time of COVID - when they have little time and maybe transportation obstacles as well.

"It's really important to me that we're able to see as many as patients as possible when it's convenient for them," Maria said. "Some people are coming here on their days off, and it might be the only chance they have to come in for a quite a while."

She said she can see how positively patients respond when she updates them frequently on what their wait-time will be if they are walk-ins. "I make sure they see that we are acknowledging their needs, and I keep them in the loop while they're waiting," she said. "They know I'm really paying attention to them."

Clinician Rachel Thornton said she always makes sure to approach patients in a way that makes them feel immediately comfortable with speaking to her about what they need.

"If I meet people on a personable level, they're much more likely to ask me questions about things they might otherwise be embarrassed to ask," Rachel said. "Even something as simple as starting out our visit with a question like, 'How is your day going?' can really make people feel more comfortable about talking about what they need or what's been bothering them.

"The idea is for patients to feel as welcome as possible, that they've come to the right place."

PPMM Education staffers get certified in mental health first aid (MHFA)

The pandemic has underscored the need for everyone to protect and seek care for their mental as well as physical health, and this is especially important for our students or young people who are pregnant or parenting for the first time. PPMM Education is pleased to announce that two case managers in our Santa Clara County-based Teen Parent Support Program (TPSP) are now certified instructors in mental health first aid (MHFA) through the National Council for Mental Wellbeing. An Education Services program manager will also be completing the training this fall.

TPSP Senior Case Manager Mindy A. and Case Manager Delia N. are the first team members to become certified instructors and can now train others, virtually or in person, in the skills to reach out and provide initial support to someone who may be showing signs of distress or a personal mental health crisis.

As case managers, Mindy and Delia have had many trainings in this area, but they said this particular training gave them a new perspective on how they view mental health, including being able to help others who may be in crisis.

"Most people know how to provide first aid when you cut your hand or smash your finger," Delia said. "But very few know what to do when someone needs first aid for mental health."

Mental health first aid is an evidence-based program proven to be effective in teaching adults how to recognize and respond to signs and symptoms of mental health and substance use challenges. It is designed to be taught to any adult – no

Trained folx increase their confidence in helping and are more likely to intervene with an individual in distress. They also show increased mental wellness themselves.

Mindy explained that the training is an extremely helpful tool for our TPSP case managers. "Perhaps a young mom participant is experiencing sadness after her having her baby, and she seems to have some trouble bonding. This emotion is unusual for her, and she sometimes says she is not a good mom," Mindy said.

"MHFA provides the tools to identify a mental health challenge, like when to call 911

or help the participant connect with community or professional support."

People from many different professions and life experiences are trained as "mental health first aiders," with the national council's goal to make MHFA as ubiquitous as CPR training. In the course that PPMM Education can now offer, folx learn an evidence-based action plan process that can help them identify risk factors and warning signs for mental health and addiction concerns. Trainees can also learn strategies for how to help someone in crisis and non-crisis situations as well as where to turn for help. For now, the Education team is looking forward to completing the training by March 2022. Then PPMM Education will begin offering MHFT to PPMM staff who are interested. PP triumph in the CA legislature! Gov. Newsom signs two PPAC-sponsored bills

On September 22, California Gov. Gavin Newsom signed into law two bills sponsored by Planned Parenthood Affiliates of California: AB 1184 protects patients by ensuring that they will be the sole recipients of confidential communication from their insurance companies. AB 1356 strengthens the safety and security of health centers, like PPMM's, across the state.

Public Affairs engaged voters in California's Sept. recall election

The Public Affairs team, in partnership with the Volunteer Services and Creative teams, launched a voter engagement campaign to create awareness of the California Recall Election, encouraging voter registration and mailing in ballots.

We joined with community partners like the Latina Coalition of the Silicon Valley to provide informational Zoom events about the special recall election on September 14. The Latina Coalition was so impressed by the presentation that they provided a Spanish translation of the slide deck for PPMM and other community groups to share with their Spanish-speaking constituencies.

The P.A. team also provided voter-engagement presentations by working with traditional organizations, such as the League of Women Voters, as well as more diverse organizing groups including the Black Organizing Project, Little Manila Organization, Alliance for Girls, affiliate-wide LGBTQ+ organizations, and community colleges as far south as Bakersfield. A total of 16 organizations participated in Zoom events and were encouraged to use the PPMM voter-engagement slide deck to inform and engage their staff and community constituents.

Our team members also partnered with San Joaquin Magazine and Radio Bilingue to promote voting in the recall election. Volunteer Services held two virtual events to engage voters, and the Creative team joined the effort by providing outreach through emails to our supporters and on PPMM's social media platforms.

Launching this voter-engagement campaign was also a great way for PPMM to honor the 110th anniversary of most California women winning the right to vote, in October 1911, nine years before the passage of the 19th Amendment.
