PROPOSITION 1

CONSTITUTIONAL RIGHT TO REPRODUCTIVE FREEDOM

SUPPORT

Proposition 1 will place the right to abortion in the California State Constitution to declare that individuals have a fundamental right to choose to have an abortion and to use or refuse contraceptives.
