America's Abortion Crisis

Almost 50 years after Roe v. Wade – the fight to protect abortion continues.

Abortion access is in crisis in America.


It has been almost 50 years since the landmark decision in *Roe v. Wade* protected the fundamental right to safe, legal abortion. Since then, states across the country have passed hundreds of laws to regulate and restrict abortion. These laws limit whether, when and under what circumstances a person may obtain an abortion. While abortion has remained legal, politicians have worked relentlessly to dismantle access to this essential health care service.

Thanks to the incredible work of Planned Parenthood supporters like you, people across the

country have been able to receive the abortion care they need and deserve. Yet, bans and state regulations continue to make it harder to access care; in many places, abortion rights are meaningless because access to care is so severely restricted.

According to the Guttmacher Institute, 2021 is the worst year for abortion access since 1973, when Roe was decided. Nearly 600 abortion restrictions have been introduced this year across 47 states. While many of these won't pass into law, 83 abortion restrictions and 10 bans have been – preventing patients across the country from getting the care they need.

Drivers of systemic barriers to care like racism, xenophobia, misogyny, homophobia, and transphobia mean that people of color, people with low incomes, members of the LGBTQ+ community, undocumented patients, and anyone who can't travel for care will bear the heaviest burden of these bans.

THE PRICE OF ABORTION BANS

The financial costs for a person traveling from a state with abortion bans to receive an abortion at PPSNE

ABORTION & DOCTOR'S VISIT

\$780

*Abortions are not covered by Medicaid in Rhode Island, and often commercial insurance that does cover abortions have very high deductibles. Abortion costs can go up to \$900 depending on gestational age and sedation. \$780 is the average charge for a surgical abortion, prior to applying for any abortion assistance funds.

GAS

\$100

934 miles roundtrip to the nearest out of state clinic.

*Average: \$2.80/gallon for September 2021.



HOTEL

\$400

2 nights including taxes and fees.

On September 1, a radical and extreme abortion ban went into effect in Texas that outlaws abortion at six weeks – before many people know they're pregnant. Emboldened by this action, other states are finding new ways to restrict or eliminate abortion access. Politicians in Florida, South Carolina, Ohio, Wisconsin, Missouri, and many other states have taken steps to follow Texas' playbook.

The U.S. Supreme Court also failed to protect patients - in a 5-4 ruling, the court allowed the Texas ban to go into effect. The court's inaction is alarming and rasies questions about the future of *Roe v. Wade*. On December 1, the court will also review Mississippi's 15-week abortion ban, potentially overturning Roe and paving the way for more than half of U.S. states to ban abortion or make an abortion nearly impossible to obtain.

This is a red alert moment for reproductive freedom. Now is the time to speak up and take action.



ABORTION POLICY BY STATE, WITHOUT ROE V. WADE

Only 13 states - including Connecticut and Rhode Island - have laws protecting the fundamental right to abortion. If *Roe v. Wade* is overturned, abortion will be immediately outlawed in more than a dozen states with bans already on the books and give anti-abortion politicians the chance to pass increasingly restrictive laws across America.



Note: Arkansas and Mississippi have pre-*Roe* bans and post-*Roe* trigger laws. Oklahoma and Texas have pre-*Roe* bans and trigger laws that will go into effect later this year. Alabama has a pre-*Roe* ban and post-Roe restrictions. The New Mexico legislature repealed a pre-*Roe* law banning abortion as of June 18, 2021.

» WHAT WE CAN DO

State laws protect the right to abortion in Connecticut and Rhode Island no matter what happens at the federal level - but we know that for too many patients, abortion access remains out of reach.



PPSNE Education in Action: Go Beyond the Birds and the Bees

Virtual program provides science-based, sex-positive, inclusive sex ed for all.

For the last year, PPSNE educators have been revamping a signature program to help ensure students receive the high-quality sex ed they deserve. Beyond the Birds and the Bees, a six-session virtual program that allows high schoolers to participate wherever they are (often from a smartphone). The program is inclusive and affirming to all identities and experiences. It is rooted in research and driven by the needs of the communities we serve; sessions include information about anatomy, sexual health, healthy relationships, gender identity/expression, and sexual orientation.



Quality sex education must be comprehensive, honest, inclusive, and sex positive. Young people need information about safer sex, sexuality, relationships, and contraception, so they can make healthy decisions, protect themselves, and plan for their futures. Sex education programs need to be informed by evidence and empower young people with knowledge and information they need to make healthy decisions.

Inadequate sex ed further stigmatizes and alienates youth; it also puts young people at greater risk of unplanned pregnancy, contracting STDs/STIs, and struggling to get help in an abusive or harmful relationship.

Education is central to the mission of Planned Parenthood - and your investment in PPSNE makes these programs possible.

During our Pilot Program:


93% of participants learned new things

More than **75%** felt comfortable talking to their partner about sexual health and felt confident they could make healthy decisions about their sexuality.

80% said they would be comfortable talking about their sexual health

At the start of the program, less than half of participants felt comfortable talking to a health care provider about sexual health topics that changed drastically after completing the program. Programs like Beyond the Birds and the Bees provide a safe space for teens to explore their sexuality, ask questions and become better informed - helping them develop healthy habits and make important decisions about their lives. You help make this possible!

- this program had real world scenarios, and we got to discuss them together and learn from each other."

Care - and Access - No Matter What

PPSNE works with all types of insurance to meet patients' need.

Enrolling people in private insurance plans on the Affordable Care Act marketplace, like Access Health in Connecticut or HealthSource RI – or, if eligible, Medicaid programs – is a meaningful way to welcome people into a health care system that has too often left them behind.

Your support allows us to invest in enrollment specialists like Jasmin Osorio, who works one-on-one with patients to ensure they can access the lifesaving services they need. In just the past 18 months, Jasmin has worked with over 300 patients, helping most obtain health insurance through Medicaid or a qualified private insurer at a reduced price, such as ConnectiCare or Anthem.

That's one way the Planned Parenthood experience is unique. Not all health centers or providers take the time to enroll patients in health insurance — or have the advanced skills to navigate the insurance market in two states.

"We are happy for our patients to get coverage because we know that they are being taken care of as a whole," Jasmin explained. That's the power of PPSNE, and it's people like you who make it possible.


"There was a woman recently who had a few medical issues, and, without insurance, she'd been waiting to see a provider. She was having a hard time getting enrolled in insurance and was overwhelmed by the process - it was very challenging for her. If she couldn't get care in Connecticut, she was afraid she'd have to move back to another state, and she didn't want to move."

Jasmin continued to advocate for her patient. "I got her enrolled, but the specialist she needed to see wouldn't take her insurance. I connected with a social worker who manages

Medicaid cases, and together we figured out the problem - and got the patient the medication she needed. She was so grateful Planned Parenthood could be there for her."
