LETTER FROM THE CEO Update on the battle for reproductive rights – and our new health centers

Hello Friends,

I'm sure you were just as appalled as I was when you heard the recent devastating Alabama Supreme Court ruling that said frozen embryos in test tubes should be considered "children." In this case, families who had embryos that were accidentally destroyed at a fertility clinic had sued the clinic for wrongful death.

This decision, which is medically and scientifically unfounded, is part of the avalanche of destructive, oppressive court rulings and legislation that has crashed down across the country since *Roe* was overturned.

The Alabama ruling advances the far-right wing's attempts to create "fetal personhood" and calls into question the legality of in vitro fertilization (IVF) as well as other fertility medicine services. It also sets the stage for even more policies that punish pregnant people and strip away their rights. It is off-the-rails extreme – and dangerous.

That brings me to the tireless efforts to continue protecting and promoting reproductive freedom in the states that PPMM serves.

In Nevada, Planned Parenthood Advocates Mar Monte is working in coalition with other partner groups in the state, collecting signatures to place a measure on the ballot in November that will enshrine abortion rights into the state constitution. This is similar to California's Prop. 1, the reproductive-rights ballot measure that passed overwhelmingly in 2022.

We've already seen the harm that abortion bans have caused across the country, including in Nevada's neighboring states: Idaho has a total ban, and Utah has a very fragile 18-week ban.

Groups that are gathering signatures for the state constitutional amendment in Nevada are very optimistic that they will have enough to place it on the November 5th ballot – less than 250 days from now.

A clear majority of Nevadans support the right to abortion as well as a constitutional amendment to protect reproductive freedom. According to a 2023 poll by The Nevada Independent, 62% of Nevadans support the amendment – regardless of party affiliation.

#### New health centers

To close on a very positive note, I want to catch you up on what's happening with our newest health centers and what great news it is for our patients.

Our center in Reno that opened late last year is nearly three times larger than the former site, including space to provide procedural abortions. It's been embraced by our patients and is far more accessible for those coming from long distances to receive care.

Our new Mar Monte Community Clinic (MMCC) site in East San Jose also opened recently at the end of January.

We will be having ribbon-cutting ceremonies at both of these beautiful buildings in March.

Meanwhile, we are starting our most ambitious health center-construction project yet in downtown Oakland, at a location that's very accessible by BART and bus, including for patients who come in from the airport. Staff at the current Coliseum health center will move in December to the new site, which will be 12,000 square feet and have 19 exam rooms, including space that will serve as a training center for us.

We'll keep you posted at the end of the year about the opening of this new health center that will also have fantastic murals, painted by local artist Jessica Sabogal.

As always, I thank you for your tireless support of our patients and making sure we can tell them that PPMM is here for them, no matter what.

### **PPMM prenatal care in Fresno** A Q&A with our CMOO, Dr. Laura Dalton

PPMM's re-vamped prenatal care program is serving patients at Vera Broder Silberstein health center in Fresno, fully integrated into the health center's family medicine services. The FMM recently sat down with PPMM Chief Medical Operating Officer Dr. Laura Dalton to find out more.

**Full Mar Monte:** Dr. Dalton, can you tell us a little about the history of prenatal care services at PPMM and how the program was reimagined?



**Dr. Laura Dalton:** Prenatal care was provided for many years at PPMM, and, in 2016, the program was put on pause so we could really think and evaluate how best to provide the service, moving forward.

We spent a few years evaluating and optimizing programs so that we could provide prenatal care in a team-based approach. We were really thinking about our patients and how to provide prenatal care in a comprehensive way that integrates into our family medicine program, ensuring the best possible outcomes and the best experience for our patients and their children and partners.

We relaunched the program at this health center because it serves an area of documented need for these services, and we have the ability to have relationships with local delivering providers. Also, we received critical financial support for the program thanks to a generous donation several years ago from Vera Broder Silberstein (whom the Fresno center has been named for).

FMM: What makes our prenatal program special?

**Dr. Dalton:** Often, when patients are attempting to access prenatal care outside of PPMM, they have to wait until a certain number of weeks or gestational age before that health center will accept them into their prenatal program. At PPMM, we're experts in early pregnancy.

One of the things that's different about our prenatal care is the way that we design the program, the oversight, and the structure of the teams providing the care. It all comes back to this team-based approach where we think about Planned Parenthood Mar Monte health centers being a health home.

There's a whole team of people who are invested in you and your health, your life, and your family. They're working together to really combine different areas of expertise and ways of thinking about prenatal care to create one of the most unique comprehensive programs.

FMM: What is the significance of the prenatal care coordinator role?

**Dr. Dalton:** The care coordinator is responsible for going through all the education; the what to expect during your prenatal time at Planned Parenthood Mar Monte, and to do coordination of visits, answer questions, and connect the patient to a provider when there are any types of issues. It really takes that whole team to provide care that's different than someone may experience at another facility.

**FMM:** How do PPMM family medicine services integrate with the prenatal care we provide?

**Dr. Dalton:** So, imagine a woman at her first postpartum visit: We can make sure that she's recovered well from her delivery. We can talk about breast-feeding, we can talk about contraceptive needs for her, and then we provide the first newborn visit for her baby.

She doesn't have to take another trip to another health center. And then we can also check in on the partner and other family members that are providing support for her.

This can be a huge change for many members of the family and the social support networks for our patients. So being able to provide comprehensive family medicine to those members, all in the same visit, can be really impactful for patients.

FMM: Do we have plans to provide prenatal care services in our other health centers?Dr. Dalton: PPMM would like to expand prenatal services, and our staff are eager to provide this care at our other sites. So we are working to be able to do that!

#### Listening to patients' health stories Clinician Christine S. at MMCC

Here's what a patient had to say about a recent visit with Clinician Christine S. at the Mar Monte Community Clinic (MMCC) in San Jose:

"Christine was incredibly kind and caring. I would definitely recommend her to others needing assistance with their reproductive issues or concerns. Christine made it easy to open up to her about my concerns, without any judgment. She made the entire experience very comfortable for me, and I appreciate her professionalism."

One of the first things that MMCC Clinician Christine S. communicates to patients when she comes into the exam room is that she's ready to listen.

"I want patients to feel that this is a safe space to talk about their situation," she said. "I'm going to answer their questions – but not tell them what to do. I want them to understand right away that I know it's their decision, and I'm going to support that. "

Christine said one of the best ways to make patients feel comfortable is to encourage them to say everything they want her to know about why they have come in: "I listen to their stories and let them know that I want them to ask whatever questions they have."

Patients have told her at the end of their appointments how much they appreciated her listening to all their concerns whether it was about recurring symptoms, how medication might affect them, or what would be the best care regimen for the way they live.

"Sometimes patients will come in for reproductive health care, and, after I hear their questions, I tell them we can set them up here for primary care as well," Christine said. "I want them to know that this is a place they can come back to, where they will be cared for and always be listened to."

#### **Investing in young parents in Santa Clara County** Teen Parent Support Program

#### What is TPSP?

TPSP is a comprehensive case management program for expectant and parenting youth in Santa Clara County who are up to age 21. Here's a quick snapshot of one of PPMM Education's longest-standing programs: the Teen Parent Support Program (TPSP).

The program has been funded for more than 16 years through an annual services contract of nearly \$1 million from the SCC Public Health Department and Social Services. Through the contract, TPSP provides the county's qualifying youth with a dedicated PPMM Education case manager who uses an approach that promotes resiliency, autonomy, and a sense of purpose.

Case managers support pregnant or parenting youth to set and reach their goals, encourage a healthy and nurturing environment for themselves and their families, and help them to get their high school diploma, GED certificate, or post-secondary training or education.

- Who: Young parents of any gender, regardless of residency status and/or health insurance statusAge: Up to 21-years-oldWhere: Santa Clara County
- Format: Hybrid in-person and virtual comprehensive case management and youth development program Languages: English and Spanish with interpreter options for other languages
- **Duration:** Until age 21; most young parents participate for 12- to 18-months on average. If they stop, they can re-enroll **Annual # of participants:** 280

TPSP's seven case managers visit participants at home, school, and in the community twice a month as well as conducting virtual visits via video calls. (See p. 7, PPMM case managers talking about why they love their work.)

Nearly 4,300 young parents have been served through TPSP and Cal-Learn since 2007, in partnership with the county.

#### **TPSP Success Stories**

**Maria\*, 21,** was originally referred to TPSP in 2017 when she was 14 and pregnant with her baby. Maria graduated from high school in 2022, while working part-time at McDonald's. Soon after graduation, she started working at an optometrist's office full-time.

Last September, she started a medical assistant program in the Mountain View Los Altos Union High School District. In addition, Maria has been offered local employment in health care once she completes her program.

What else does TPSP offer young parents? Resource referrals and connection. Thanks to donations from our generous partners and other community organizations, like The MOCA Foundation in Gilroy, TPSP offers diapers, baby wipes, formula, baby clothes, coats, blankets, baby books, hygiene and personal items upon request and based on available supplies.

TPSP also offers young parents kits with items such as condoms, tampons, and sex-ed learning materials. We've even been able to connect young parents with organizations that provided birthday cakes, and we have held an annual baby shower for participants. We're currently exploring offering in-person, peer-led support groups throughout the year. Maria's daughter is now six years old and enrolled in Kindergarten, after completing Transitional Kindergarten (TK) last year. TPSP Case Manager Cerina C., who has been Maria's case manager since 2020, reflects: "It has been a great pleasure to work with Maria these past three years and see how our program truly does provide support for our participants."

With additional support of funders like the MOCA Foundation, a family foundation in Gilroy, TPSP donates young parents' most-requested items including diapers, children's learning toys and books, baby formula, and seasonal clothes.

**Does PPMM offer case management services for young parents beyond Santa Clara County?** In FY23, PPMM Education conducted a study to investigate what other programs and resources are available for young parents throughout the affiliate's 42 counties.

Director of Youth Development Jeanette M., who leads TPSP, explained, "If a county doesn't have funding from the state for a comprehensive case management program, such as the Adolescent Family Life Program, there aren't many options.

#### **TPSP Success Stories**

**Kaitlyn\*, 21**, enrolled in TPSP at the beginning of her sophomore year at Stanford University. Although she was awarded a full scholarship, she was struggling financially due to: Child-care costs (\$1,000 per month), unreliable financial contributions from her son's father, difficulty navigating Medi-Cal enrollment, and managing her documented depression, anxiety, and toxic stress after experiencing childhood trauma and intimate partner violence as a teen.

**Cerina C.**, *Case Manager*, 5 years, "My favorite thing about working with young parents is having a front-row seat to them accomplishing goals and hitting pivotal milestones. It's really inspiring to be there with them through those times."

With the help of her TPSP case manager, Ashley W., Kaitlyn achieved all this while continuing to excel as a full-time student, focusing on healthy parenting, and supporting her son's development in his verbal skills.

At the start of her junior year of college, Kaitlyn was working toward completing her bachelor's degree in ethnic studies and her master's in education. She is looking forward to returning home to support the migrant worker community through a career in education and advocacy.

When she's not at work, Annie says you can find her spending time with her wife and two dogs, outdoors – or sometimes winning with her kickball team!





A recent groundbreaking event in Visalia brought together leaders of the Central Valley Reproductive Justice Coalition – including PPMM, ACT for Women and Girls, The Source LGBTQ+ Center, and others – to offer workshops for young activists who are committed to doing reproductive justice work in their communities.

Inspiring young people to get involved with this work and supporting those who already are is a key part of changing the current harsh national landscape for reproductive rights and access to health care for all.

The "Healing the Past, Shaping the Future Summit" in early February, at the College of the Sequoias in Visalia, provided a space for young people and other community members to come together and drive conversations about health care as well as reproductive rights and justice.
