2022 PLANNED PARENTHOOD ADVOCATES PASADENA & SAN GABRIEL VALLEY

In 2022, the Supreme Court of the United States (SCOTUS) overturned Roe v. Wade, taking away the right to abortion from millions of Americans. Their decision unleashed fear, chaos, and uncertainty across the country as individual states suddenly had the power to enforce abortion restrictions or outright bans on the procedure. Many out of state patients sought care including at local Planned Parenthood Pasadena & San Gabriel health centers.

Planned Parenthood Advocates responded by advocating at the federal, state, and local levels to enact laws, policies, and budget allocations that protect and expand access to abortion and other life saving health care.

OUR FEDERAL IMPACT

LOBBIED:

- In support of the Women's Health Protection Act
- In support Medicaid's free choice of provider requirement to ensure enrollees can access care with providers they know and trust, like Planned Parenthood
- In support of funding for International U.S. Family Planning and Reproductive Health Programs

MOBILIZED:

- Planned Parenthood Advocate volunteers to canvass in Las Vegas for Catherine Cortez-Masto for US Senate
- Knocked on over 250 doors in hard-to-reach Las Vegas neighborhoods

LOBBIED:

 State legislators during Capitol Week to successfully pass over a dozen bills and secure a +\$200 million investment for sexual and reproductive health carethe largest ever in California history

CONTRIBUTED:

- \$25k to the Yes on Prop. 1 statewide campaign
- \$1k to Assembly Member Mike Fong campaign (AD 49)

ENDORSED:

Chris Holden (AD 41) & Mike Fong (AD 49) for CA State Assembly

MOBILIZED:

- Planned Parenthood Advocates volunteers in the Yes on Prop. 1 Day of Action text bank event
- Launched an email and social media voter outreach campaign

CONTRIBUTED:

• Over \$7,000 in political campaign contributions

ENDORSED:

 13 local candidates to City Councils, School Boards, and Community College Board of Trustees throughout the San Gabriel Valley

MOBILIZED:

 Hosted an election webinar to educate voters about PP Advocates endorsed candidates, ballot measures, how to cast and track ballots
