# What's going on with mife?

Dear Supporter,

#### What a week...PPFA President Alexis McGill has this to say:

"After a week of chaos and confusion, the Supreme Court appropriately decided to allow mifepristone's status to remain as it has been — approved and accessible — as the case continues, after two disastrous decisions were issued by lower courts. But this fight does not end here: the Supreme Court must reject this effort to insert personal and political grievances into the FDA approval process and further restrict abortion.

Patients deserve access to the medication they need and providers should be able to provide that medication without unnecessary interference from the judiciary, or politicians for that matter. Mifepristone's approval is very much still in jeopardy, and in the midst of the abortion access crisis, this medication must be protected."

## What's happening at the Montana State Legislature?

HB 303: Religious/Ethic/Moral Refusal for Medical Care - Sponsored by Rep. Amy Regier

This would allow any medical provider, medical institution and/or insurer to deny care to any person for any reason based on religious, ethical or moral reasons. It's a very broadly written bill that could allow any person who works at a facility, from a janitor, front desk scheduler, surgery tech, or physician, to deny care. Abortion is the only procedure specifically carved out in this bill.

This bill was passed in both chambers. Please call the Governor's Office at 406.444.3111 and urge Gov. Gianforte to veto HB 303.

HB 862: Prohibit Use of Public Funds and Exceptions - Sponsored by Rep. Hopkins

This would be a functional ban on accessing abortion care for people who receive Medicaid. Bills like this are reckless - they do not stop abortions, they simply put people's lives and health in danger.

This bill passed out of the Senate Public Health Committee on Wednesday and is now heading to the Senate floor. Please contact your Senator and ask them to vote NO on HB 862.

**HB 575: Prohibit Abortion of Unborn Viable Children** – Sponsored by Rep. Sheldon-Galloway

This bill seeks to require a physician or physician assistant to put in writing the determination of viability and provide that to the patient. HB 575 was recently amended to add a mandatory ultrasound, and passed out of the Senate earlier this week. Since it was amended, it is now being sent back to the House.

Please contact your Representative and ask them to vote NO on HB 575.
