

PPNNE provides high-quality sexual and reproductive health (SRH) care through 21 health centers across Maine, New Hampshire, and Vermont, as well as a new telehealth program. Patients receive vital services such as well-person exams, cancer screenings, birth control counseling and access to the full range of contraceptive methods, emergency contraception, abortion care, STD testing/treatment/prevention services, immunizations, gender affirming hormone therapy, and other limited primary care. Highlights of our work meeting patient need from 1/1/20-6/30/20 include:
-Quickly transforming our care delivery model when the COVID-19 pandemic arrived, to continue providing essential SRH care while protecting the health and safety of patients and staff. This included

PPNNE reaches and engages youth and adults, with a focus on the sexual and reproductive health (SRH) needs of underserved and at-risk populations, through community outreach and collaborations, trainings, events, and education programming. In the context of the pandemic, we leveraged technology and adapted this work for virtual connection to keep everyone safe. Highlights include:
-Conducting 87 outreach activities across our region to deepen referral relationships with other health and human service organizations, raise visibility, and bring services and education to more people.
-Advancing special proactive initiatives (as funding allows) to improve public health, address health inequities, and reduce unintended pregnancy, with downstream impacts on individuals, families, and

PPNNE's organizing and policy program integrates public education, advocacy, collaboration, media strategies, and grassroots mobilization. These efforts are conducted in tandem with Planned Parenthood Action Fund organizations in Maine, New Hampshire, and Vermont and in collaboration with community partners. This state-level work including advocating for sexual and reproductive health and freedom, expanded health care access, and other beneficial policies reduces unintended pregnancy and promotes public health, equity, and economic security statewide. Highlights from the first half of 2020 include collaboratively defeating all anti-reproductive bills; continuing work to advance the multi-year effort to enshrine reproductive liberty in the Vermont constitution (Prop 5); supporting policies to expand access

In response to the pandemic, PPNNE developed and implemented several service expansions to meet patient needs safely and effectively. Most significantly, we launched a new telehealth program serving Maine, New Hampshire, and Vermont, which allows patients to access high-quality, affordable health care services by phone or through a private and secure video conferencing platform that connects them with PPNNE providers. Additional examples include incorporating our integrated behavioral health program into the telehealth program and preparing to hire more licensed mental health professionals later in the year, developing an at-home testing option for certain STDs (gonorrhea, chlamydia, and trichomoniasis) and an at-home option for birth control shots, and laying groundwork to begin offering medication abortion at our Topsham, ME health center, which began in late 2020.

When the COVID-19 pandemic began, we quickly transformed our care delivery model and never stopped serving patients. We began providing as much care as possible via telehealth, while seeing patients in-person as needed and with a range of safety precautions and policies in place (personal protective equipment (PPE), screening patients and staff, requiring masks, social distancing, enhanced cleaning/sanitizing, ventilation management, etc.). We also adapted our outreach, education, and public affairs programming for virtual connection to keep everyone safe.

-Meeting the SRH needs of 20,655 patients through 27,115 visits (in-person and telehealth visits combined).

-Contributing to important patient and societal outcomes. Based on formulas developed in peer-reviewed Guttmacher Institute research (www.guttmacher.org/broader-benefits/), we estimate that PPNNE helped patients prevent approximately 3,400 unintended pregnancies, resulting in net public cost savings of \$16.8 million.

-Serving a predominantly low-income, underinsured, and young patient base. During this period, 69% of our patients were low-income (at or below 200% of the federal poverty guideline, or \$25,520 for one person), 43% were living below the poverty line (\$12,760 for one person), 20% were uninsured/self-pay, and 35% had coverage through Medicaid or another public program. Our patient base was also overwhelmingly female (88%) and young, with 67% under the age of 30 (14% teens and 53% in their twenties).

-Ensuring access for uninsured/underinsured patients by delivering over \$3.2 million in free/discounted health care through our sliding fee scale program.

-Offering expanded support to Vermont patients through PPNNE's integrated behavioral health program, which embeds licensed mental health professionals in our health centers. This care shifted to telehealth delivery under the pandemic.

-Finishing the relocation of our Sanford, ME health center in February

to a larger and efficiently designed new space, bringing the total number of transformed health centers to 15. These projects, which expand access and enhance the patient experience, are funded with dedicated dollars raised through PPNNE's last capital campaign -Achieving a very high level of patient satisfaction. Highlights of survey results include that: patients felt the services offered met their needs (scoring 96.3 out of 100 points), staff protected their safety (96.2/100), they were treated with compassion and respect (97.1/100), and our clinicians spoke using clear language (96.9/100). As a result, patients were extremely likely to recommend PPNNE to others (96.9/100).

Examples of this work from 1/1/20-6/30/20 included delivering virtual trainings on family planning needs/referrals, contraceptive counseling, and other SRH topics to community health and social service professionals; providing resources to community partners; and conducting a community needs assessment focused on SRH access for people with limited English proficiency, developing recommendations that PPNNE has begun advancing through a long-term initiative.

Under the pandemic, we shifted to a remote model for peer education with virtual engagement activities. This included collaboratively planning the second Vermont Youth Sex Education Summit, which was successfully held via Zoom in December.

For instance, when the pandemic began, we quickly assembled a set of online sex education resources to help teachers adapt their in-person curricula. We also adapted our youth sexual health services training and resource binder for online delivery (and expanded the content), and continued helping youth-serving professionals to more confidently and accurately discuss SRH (including sexuality, birth control, STDs, healthy relationships, and other topics) and connect their students/clients with PPNNE and other community resources.
